Pursuant to Section 22-2536, Idaho Code, Bee Inspection Law, the registration fee is \$10.00 for the first 50 colonies. Each additional colony in excess of the first 50 colonies shall be assessed at the rate of \$0.10 per colony. Pursuant to Section 22-2808, Idaho Code, Honey Industry Law, an annual tax of \$0.05 per hive or colony is levied to fund the Honey Commission. **Please note:** if you are a hobbyist beekeeper registering 50 colonies or less, your fee is \$10.00. In this situation, do not use example below.
